RESOLUTION NO. 590-2023

DECLARING ORDINANCE NO. 02-2023 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED “AN ORDINANCE ADOPTING THE REGISTRATION OF MUNICIPAL FISHERS AND FISHING VESSELS, THREE (3) GROSS TONS AND BELOW AND LICENSING OF FISHING OPERATIONS IN THE MUNICIPALITY OF ANDA, PANGASINAN AND IMPOSING PENALTIES IN VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 02-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 132, 149 (b) (3) & 447 (a) (3) (i) of R. A. No. 7160; Republic Act No. 10601, otherwise known as “Agricultural and Fisheries Mechanization Law”; Joint Memorandum Circular No. 2018-02; Executive Order No. 305 or the “Devolving to the Municipal and City Government the Registration of Fishing Vessels Three (3) Gross Tonnage Below; and Republic Act No. 8550 known as the “Philippine Fisheries Code of 1998”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
