DECLARING ORDINANCE NO. 16-2023 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF YOUTH DEVELOPMENT OFFICER I UNDER THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT OFFICE OF THE MUNICIPALITY OF ANDA, PANGASINAN THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Ordinance No. 16-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was–

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 16-2023 of the Sangguniang Bayan of Anda, Pangasinan, entitled "An Ordinance creating the position of Youth Development Officer I under the Municipal Social Welfare and Development Office of the Municipality of Anda, Pangasinan thereof" as within the conferred powers of the Sangguniang Bayan to enact;
