DECLARING ORDINANCE NO. 21-2023 OF THE SANGGUNIANG BAYAN OF ANDA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF SLAUGHTERHOUSE MASTER I UNDER THE OFFICE OF THE MUNICIPAL AGRICULTURIST OF THE MUNICIPALITY OF ANDA, PANGASINAN THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
