**RESOLUTION NO. 595-2023**

**DECLARING ORDINANCE NO. 02-2023 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING AND/OR LOCALIZING, THE IMPLEMENTATION OF REPUBLIC ACT 8972, ALSO KNOWN AS THE SOLO PARENT WELFARE ACT OF 2000" AND PROVIDING FOR EXPANDED BENEFITS TO SOLO PARENTS AND THEIR CHILDREN; APPROPRIATING FUNDS THEREFORE AND OTHER PURPOSES FOR LOCAL IMPLEMENTATION IN THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Burgos, Pangasinan submitted its Ordinance No. 02-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Local Finance Committee of the Province and the Provincial Social Welfare and Development Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iv) of R. A. No. 7160; Republic Act No. 8972 otherwise known as the Solo Parents Welfare Act of 2000; Republic Act No. 11861 or the "Expanded Solo Parents Welfare Act and Memorandum Circular No. 08, S.2004, issued by the Civil Service Commission with the subject entitled "Guidelines on the Grant of Parental Leave to Solo Parents";

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 02-2023 of the Sangguniang Bayan of Burgos, Pangasinan, entitled “An Ordinance adopting and/or localizing, the implementation of Republic Act 8972, also known as the Solo Parent Welfare Act Of 2000” and providing for expanded benefits to solo parents and their children; appropriating funds therefore and other purposes for local implementation in the Municipality of Burgos, Province of Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
