APPROVING RESOLUTION NO. 152-2023 OF THE SANGGUNIANG BAYAN OF URBIZTONDO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 2 FOR CY 2023 OF THE MUNICIPALITY OF URBIZTONDO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Urbiztondo, Pangasinan submitted its SB Resolution No. 152-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- 1. The Municipal Development Council of Urbiztondo, Pangasinan prepared their Supplemental Investment Program (SIP) No. 2 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 03, S-2023 dated May 18, 2023, to the Sangguniang Bayan for approval. This is in consonance to Section 106, 109 and 114 of the Local Government Code of 1991; and
- 2. Said Supplemental Investment Program, which has a total investment requirement of ₱243,350,125.00, covers various priority development projects of the municipality to be funded from the loan proceeds of the LGU from the Land Bank of the Philippines.

WHEREAS, however, the LGU shall prepare a Supplemental Budget once their loan is approved to ensure the full implementation of the projects embodied in their Supplemental Investment Program;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Urbiztondo, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
