## **RESOLUTION NO. 597-2023**

APPROVING RESOLUTION NO. 61-2023 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2023 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its SB Resolution No. 61-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Municipal Development Council of San Jacinto, Pangasinan prepared the municipality's Supplemental Investment Program No. 1 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 2023-01 dated March 14, 2023 to the Sangguniang Bayan for approval. This is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991;
- Said Supplemental Investment Program covers the Construction of Bridge in Barangay Bolo, San Jacinto to be funded from the Local Government Support Fund-Financial Assistance (LGSF-FA) of the national government in the amount of P12 Million; and

> The aforementioned project is based on Local Budget Circular No. 150 dated March 8, 2023 (Guidelines on the Release and Utilization of the LGSF-FA to LGU's) of the Department of Budget and Management.
