RESOLUTION NO. 598-2023

DECLARING ORDINANCE NO. 2023-01, OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED “AN ORDINANCE UPDATING THE CODE OF CHILDREN OF THE MUNICIPALITY OF BALUNGAO, PROVINCE OF PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2023-01 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with United Nations Convention on the Rights of the Child (CRC); Presidential Decree No. 603 or “The Child and Youth Welfare Code; United Nations Convention on the Rights of the Child (CRC); Republic Act No. 7610 of 1992 (Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act) otherwise known as the Child Protection Law” and Sections 2 & 17 (b) (2) (iii) (iv)(5) (xiv) of R. A. No. 7160;


