#### **RESOLUTION NO. 599-2023**

DECLARING ORDINANCE NO. 2023-04, OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING THE USE OF PLASTIC BAGS, FILM AND SINGLE USE PLASTICS, AND STYROPHORS/STYROFOAMS IN THE MUNICIPALITY OF BALUNGAO, PANGASINAN, IMPOSING PENALTIES FOR VIOLATION AND FURTHER APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2023-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 447 (a) (iii) (5) (xiii) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
