**DECLARING ORDINANCE NO. 2023-05, OF THE SANGGUNIANG** BALUNGAO, PANGASINAN, ENTITLED BAYAN OF "AN "NO ENFORCING **MUNICIPALITY'S** ORDINANCE THE SEGREGATION. NO COLLECTION POLICY" **FURTHER** REQUIRING EVERY HOUSEHOLD, ESTABLISHMENT AND MANDATORY INSTITUTION то PRACTICE WASTE SEGREGATION AND IMPOSING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES" AS WITHIN THE **CONFERRED POWERS OF THE SANGGUNIAN TO ENACT** 

WHEREAS, the Sangguniang Bayan of Balungao, Pangasinan submitted its Ordinance No. 2023-05 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Article II of the 1987 Philippine Constitution; RA 8749 or Clean Air Act of 1999; RA 9003 or Solid Waste Management Act; RA 9275 or Clean Water Act and Sections 16, 17 (a) (2) (vi) & 447 (1) (iii) (vi) of R. A. No. 7160;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R. A. No. 7160;
