**PROVINCIAL RESOLUTION NO. 609-2023**

**APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM  
NO. 4 OF THE PROVINCE OF PANGASINAN FOR CALENDAR  
YEAR 2023**

**WHEREAS**, presented for consideration is the Supplemental Investment Program No. 4 of the Province of Pangasinan for Calendar Year 2023 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 03-23;

**WHEREAS**, Supplemental Investment Program No. 4 contains DRRM related programs, projects and activities that were not included in the approved 2023 Annual Investment Program of the Province of Pangasinan;

**WHEREAS**, the Supplemental Investment Program covers the reprogramming of the existing Local Disaster Risk Reduction and Management Fund Investment Plan (LDRRMFIP) to augment the necessary funds required for the stockpiling of food and non-food items, given the increasing demand and the critical importance of having adequate supplies readily available during the occurrence of disaster and calamities;

**WHEREAS**, the said Supplemental Investment Program likewise covers the purchase of an amphibious excavator, as this specialized equipment is essential for effective disaster risk reduction and management efforts within the province;

**WHEREAS**, said Disaster Risk Reduction related programs and projects emanated from the Provincial Disaster Risk Reduction and Management Council and approved through PDRRMC Resolution No. 2, Series of 2023;

**WHEREAS**, also included is the purchase of Ambulance with complete accessories to be funded from the reprogrammed Department of Energy/Energy Regulations 1-94 projects from SIP No. 3 CY 2022 due to changes in the Annual Work Program (AWP);

**NOW, THEREFORE**, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –


