RESOLUTION NO. 610-2023

DECLARING ORDINANCE NO. 09, S-2022 OF THE SANGGUNIANG BAYAN OF INFANTA, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR THE MONTHLY CASH INCENTIVES OF THE PRESIDENTS OF THE SENIOR CITIZENS ASSOCIATIONS IN THE MUNICIPALITY OF INFANTA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Infanta, Pangasinan submitted its Ordinance No. 09, Series of 2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with the objectives of Republic Act No. 9994, otherwise known as “Expanded Senior Citizens Act of 2010”; Sections 17 (b) (2) (iv) & 447 (a) (5) (xiv) (xvi) of R. A. No. 7160 and Article XV, Section 4 of the Philippine Constitution;
