RESOLUTION NO. 613-2023

DECLARING MUNICIPAL ORDINANCE NO. 4, S-2023 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE MARKET CODE OF MABINI, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Municipal Ordinance No. 4, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Acting Provincial Treasurer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 147, 186, 444 (a) (b) (1) (ix) and 447 (3) (i) (iii) (5) (ii) of R. A. No. 7160 and Article 20 and 22 of the Republic Act No. 7394 otherwise known as "The Consumer Act of the Philippines";

WHEREAS, the subject ordinance shall take effect after compliance with the requirements of posting and publications pursuant to Sections 59 (c), 187 and 511 (a) of R.A. No. 7160;


