**RESOLUTION NO. 615-2023**

**DECLARING MUNICIPAL ORDINANCE NO. 7, S-2023 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING A “BAGSAKAN CENTER” IN THE MUNICIPALITY OF MABINI, PANGASINAN AND IMPOSING FEES AND OTHER CHARGES ON THE USE OF ITS FACILITIES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Mabini, Pangasinan submitted its Municipal Ordinance No. 7, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 129, 132 and 447 (a) (3) (i) of R. A. No. 7160;

**WHEREAS**, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;


