RESOLUTION NO. 616-2023

DECLARING ORDINANCE NO. 185, S-2022 OF THE SANGGUNANG BAYAN OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE AMENDING THE EXISTING REVENUE CODE OF THE MUNICIPALITY OF BASISTA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 185, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Acting Provincial Treasurer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129 and 132 of R. 
