RESOLUTION NO. 617-2023

DECLARING ORDINANCE NO. 194, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE GRANTING OF FINANCIAL ASSISTANCE TO DISPLACED WORKERS IN THE MUNICIPALITY OF BASISTA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 194, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iv) and 447 (a) (5) & (xiv) of R. A. No. 7160 and DOLE Department Order No. 173, Series of 2017, entitled “Revised Guidelines in the Implementation of the Department of Labor and Employment Integrated Livelihood and Emergency Employment Programs (DILEEP)”;

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (c) of R.A. No. 7160;


