**RESOLUTION NO. 618-2023**

**DECLARING ORDINANCE NO. 195, S-2022 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING A COMPREHENSIVE NUTRITION PROGRAM TO ADDRESS MALNUTRITION AND SUSTAIN PROGRAMS FOR NUTRITION IN THE MUNICIPALITY OF BASISTA, PANGASINAN AND APPROPRIATING FUNDS THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 195, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 17 (b) (2) (iii) and 447 (a) (5) (xiv) of R. A. No. 7160; Section 15, Article II (Principle) & Section 11, Article XIII (Health) of the 1987 Philippine Constitution; Department of Health Administrative Order 2008-0029, entitled “Implementing Health Reforms for Rapid Reduction of Maternal & Neonatal Mortality”; DOH Administrative Order No. 2010-0036, entitled “The Aquino Health Agenda: Achieving Universal Health Care for all Filipinos”; and Republic Act No. 11148, otherwise known as the “Kalusugan at Nutrisyon ng Mag-Nanay Act”;


