DECLARING ORDINANCE NO. 208, S-2023 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING ONE (1) POSITION OF ENGINEER III, ONE (1) POSITION OF PHARMACIST I AND ONE (1) POSITION OF PROJECT DEVELOPMENT OFFICER I UNDER THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN, DEFINING THE DUTIES AND FUNCTIONS AND PROVIDING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
