DECLARING ORDINANCE NO. 209, S-2023 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING ONE (1) POSITION OF LOCAL LEGISLATIVE STAFF OFFICER III, ONE (1) POSITION OF ADMINISTRATIVE AIDE VI (DATA CONTROLLER I) AND TWO (2) POSITIONS OF ADMINISTRATIVE AIDE III (UTILITY WORKER II) UNDER THE DIFFERENT OFFICES OF THE LOCAL GOVERNMENT UNIT OF BASISTA, PANGASINAN, DEFINING THE DUTIES AND FUNCTIONS AND PROVIDING FUNDS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT
