RESOLUTION NO. 623-2023

APPROVING RESOLUTION NO. 2023-185 OF THE SANGGUNANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 2023-04 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN FOR CALENDAR YEAR 2023, REQUIRING A TOTAL FUNDING OF TWENTY TWO MILLION SIX HUNDRED SIXTY THOUSAND EIGHT HUNDRED NINETY FIVE PESOS AND NINETY THREE CENTAVOS (P22,660,895.93)"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its SB Resolution No. 2023-185, Series of 2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Sta. Barbara, Pangasinan prepared the LGU's Supplemental Investment Program (SIP) No. 2023-04, CY 2023. This was endorsed by the Council, through MDC Resolution No. 2023-04, Series of 2023 dated May 5, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;

2. Said Supplemental Investment Program, which has a total investment requirement of ₱22,660,895.93, covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of the LGU, and implementation of other priority projects of the municipality (P13,974,588.43) for various offices of the LGU and for the provision of agricultural inputs and infrastructure support for the tobacco farmers, to be funded from the share of the municipality from the Tobacco Excise Tax (P8,686,307.50). The projects proposed to be funded from the Tobacco Excise Tax conform with Local Budget Memorandum No. 26 dated December 14, 2022 of the Department of Budget and Management; and
3. Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 3, FY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 2023-023, Series of 2023 dated May 10, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Sta. Barbara, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Shiela Marie F. Baniqued and Vici M. Ventanilla and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 2023-185, Series of 2023 of the Sangguniang Bayan of Sta. Barbara, Pangasinan, entitled “Approving the Supplemental Investment Program No. 2023-04 of the Municipal Government of Sta. Barbara, Pangasinan for Calendar Year 2023, requiring a total funding of Twenty Two Million Six Hundred Sixty Thousand Eight Hundred Ninety Five Pesos and Ninety Three Centavos (P22,660,895.93)”;
