S-2022 OF DECLARING ORDINANCE NO. 07. THE SANGGUNIANG BAYAN OF CALASIAO, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING THE OFFICIAL INSIGNIA AND MOTTO OF THE MUNICIPAL SOCIAL WELFARE **DEVELOPMENT** OFICE OF THE AND **MUNICIPALITY OF CALASIAO, PANGASINAN, REGULATING** ITS USE AND SPECIFYING ITS PROHIBITIONS" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Ordinance No. 07, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 16 of R.A. 7160 and Section 2 of R.A. No. 8491 (An Act Prescribing the Code of the National Flag, Anthem, Motto, Coat-of-Arms and other Heraldic Items and Devices of the Philippines);

WHEREAS, subject ordinance shall take effect after the Sanguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
