APPROVING RESOLUTION NO. 360, S-2023 OF THE SANGGUNIANG BAYAN OF BAUTISTA, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 1 S. OF 2023 TO BE FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 1 CY 2023 AMOUNTING TO THIRTY MILLION FIVE HUNDRED NINETY THREE THOUSAND EIGHT HUNDRED EIGHTY PESOS AND 35/100 (P30,593,880)”

WHEREAS, the Sangguniang Bayan of Bautista, Pangasinan submitted its SB Resolution No. 360, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Bautista, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 1 CY 2023. This was endorsed to the Sangguniang Bayan for approval on May 12, 2023 by the Municipal Development Council-Executive Committee thru MDC Resolution No. 1, S. of 2023;

2. Said SAIP covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of various municipal offices of the LGU and implementation of priority projects of the municipality; and
3. Funding support for the implementation of the same in the amount of PhP30,593,880.35 is embodied in their proposed Supplemental Budget No. 1 for Fiscal Year 2022 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 1 S. of 2023 on May 29, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Bautista, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


