APPROVING RESOLUTION NO. 2023-091 OF THE SANGGUNIANG BAYAN OF LAOAC, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2 FOR CALENDAR YEAR 2023 OF THE MUNICIPALITY OF LAOAC, PANGASINAN AMOUNTING TO NINETEEN MILLION NINE HUNDRED FIFTEEN THOUSAND FOUR HUNDRED FOURTEEN PESOS ONLY (P19,915,414.00)”

WHEREAS, the Sangguniang Bayan of Laoac, Pangasinan submitted its Resolution No. 2023-091 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Municipal Development Council of Laoac, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 2 CY 2023. This was endorsed to the Sangguniang Bayan for approval on June 1, 2023 by the Municipal Development Council-Executive Committee thru Resolution No. 2023-02;

2. The SAIP covers programs and projects proposed to be funded from the share of the LGU on the FY 2020 Burley and Native Tobacco Excise Tax Collections. Said programs and projects are in accordance to the utilization guidelines of Tobacco Excise Tax as embodied in the Local Budget Memorandum No. 86 dated December 14, 2022; and
3. Funding support for the implementation of the same in the amount of PhP19,915,414.00 is embodied in their proposed Supplemental Budget No. 2 for Fiscal Year 2023 which was enacted by their Sangguniang Bayan thru Appropriation Ordinance No. 2023-004 on June 5, 2023.


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Laoac, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—


RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 2023-091 of the Sangguniang Bayan of Laoac, Pangasinan, entitled “Approving the Supplemental Annual Investment Program (AIP) No. 2 for Calendar Year 2023 of the Municipality of Laoac, Pangasinan amounting to Nineteen Million Nine Hundred Fifteen Thousand Four Hundred Fourteen Pesos only (P19,915,414.00)”;
