PROVINCIAL RESOLUTION NO. 639-2023

SIGNIFYING THE INTENTION OF THE SANGGUNIANG PANLALAWIGAN TO STRENGTHEN THE EXISTING SISTERHOOD AGREEMENT BETWEEN THE PROVINCES OF PANGASINAN AND ORIENTAL MINDORO

WHEREAS, the sisterhood relationship between the People of the Province of Pangasinan and the People of the Province of Oriental Mindoro has long been existing as the agreement was signed on September 12, 2014;

WHEREAS, it is now the objective of the present administration to renew and strengthen the sisterhood relationship between the two provinces by bolstering the friendship ties, understanding and cooperation with the Province of Oriental Mindoro;

WHEREAS, the Province of Pangasinan intends to develop a more collaborative undertaking with the Province of Oriental Mindoro and explore new areas of development for the betterment of the two provinces;

WHEREAS, the two Provinces which have a common denomination in terms of its visions, goals and aspirations in pursuing local good governance need to build a continuous contact and cordial relation with each other;

WHEREAS, the renewal of sisterhood agreement does not only strengthen the partnership between the Province of Pangasinan and the Province of Oriental Mindoro but also open up further opportunities to foster and promote programs and projects which are geared toward the mutual growth of both provinces;

WHEREAS, in the pursuit of further progress and mutual understanding, it is important to renew and strengthen the sisterhood agreement which started nine (9) years ago to forge even more the sisterhood ties between Pangasinan and Oriental Mindoro;
