**APPROVING RESOLUTION NO. 334, S-2022 OF THE SANGGUNIAN BAYAN OF BAUTISTA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF BAUTISTA, PROVINCE OF PANGASINAN UNDER MDC RESOLUTION NO. 6, S-2022 FUNDED FROM THE SUPPLEMENTAL BUDGET NO. 3, FOR CY 2022 AMOUNTING TO TWO MILLION THREE HUNDRED THIRTY TWO THOUSAND FORTY PESOS AND 08/100 (P2,332,040.08)"**

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its SB Resolution No. 334, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of Bautista, Pangasinan has identified items in their Supplemental Annual Investment Program (SAIP) No. 3 for CY 2022. This was endorsed to the Sangguniang Bayan for approval on December 22, 2022 by the Municipal Development Council Executive Committee through MDC Resolution No. 6, S- 2022;

2. Said SAIP of the municipality covers fund augmentation for Personal Services (granting of Service Recognition Incentive to officials and employees) and Maintenance and Other Operating Expenses of some municipal offices of the LGU; and
3. Funding support for the proposed SAIP, with a total investment requirement of PhP2,332,040.08 is embodied in the municipality's Supplemental Budget No.3 CY2022, which was approved and enacted by their Sangguniang Bayan on December 23, 2022 thru Appropriation Ordinance 4 S. of 2022.




