### PROVINCIAL RESOLUTION NO. 641-2023

**AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE ILOCOS TRAINING AND REGIONAL MEDICAL CENTER FOR THE IMPLEMENTATION OF THE NURSING SKILLS TRAINING PROGRAM IN THE PROVINCE**

**WHEREAS**, the Nursing Skills Training Program is a training program being offered by the Ilocos Training and Regional Medical Center to the Province of Pangasinan which shall be composed of various nursing specializations such as Maternal Health Skills Training Program, Pediatric Nursing Skills Training Program, Neonatal Nursing Competency Enhancement Program and Basic Emergency & Trauma Nursing Skills Enhancement Program;

**WHEREAS**, the Nursing Skills Training Program aims to equip and enhance the knowledge and clinical skills of the nurses in the Province;

**WHEREAS**, the Provincial Legal Office is of the opinion that the proposed Memorandum of Agreement is in conformity with the Republic Act No. 9173, otherwise known as the "Philippine Nursing Act of 2002", and that it finds to legal impediment/s on the provisions of the subject MOA;

**WHEREAS**, the Provincial Government of Pangasinan, through the Eastern Pangasinan District Hospital, in partnership with the Ilocos Training and Regional Medical Center will join efforts in conducting the program for the period from July 2023 to July 2025;

**WHEREAS**, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the Ilocos Training and Regional Medical Center, represented by Dr. Eduardo M. Badua III, Medical Center Chief;

**NOW, THEREFORE**, on motion of SP Member Shiela Marie F. Baniqued, duly seconded, it was –


