PROVINCIAL RESOLUTION NO. 642-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH JTI JISEDAL TELECOM INCORPORATED FOR THE ESTABLISHMENT OF A BUSINESS RELATIONSHIP WHEREBY JTI SHALL DESIGN, BUILD AND CONSTRUCT THE UNDERGROUND CABLING INFRASTRUCTURE FOR THE IMPROVEMENT OF THE INFORMATION COMMUNICATION TECHNOLOGY (ICT) OF THE PROVINCE

WHEREAS, the Provincial Government of Pangasinan recognizes the importance of information communication technology which plays a vital role in upscaling professional and personal lives;

WHEREAS, Provincial Ordinance No. 299-2023 of the 11th Sangguniang Pangasinan, approved on May 22, 2023, mandates all telecommunication companies, service providers and other similar entities that use overhead wires and/or cables operating within the Province of Pangasinan to install and/or relocate wires and cable system;

WHEREAS, JTI Jisedal Telecom Incorporated, a corporation duly organized and existing under the laws of the Philippines, is one of the primary providers of construction works and supply for telecommunication companies in the country;

WHEREAS, JTI Jisedal Telecom Incorporated intends to establish a business relationship with the Province of Pangasinan in order to design, build and construct the Underground Cabling Infrastructure for the improvement of the information communication technology of the Province;

WHEREAS, the Underground Cabling Infrastructure is a viable project of the Province that will convert overhead lines to the underground in order to have a sustainable, safe and clean aesthetic view of telecommunication and cable lines in the localities of the Province;

WHEREAS, the rights and obligations of both parties including the consideration and term of the Project are stipulated in the Memorandum of Agreement which shall form part of this resolution;

WHEREAS, Section 465 (vi) of RA 7160 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III and JTI JISEDAI Telecom Incorporated, represented by its President, Mr. Christopher G. Duenas;

NOW THEREFORE, on motion of SP Member Napoleon C. Fontelera, Jr., duly seconded, it was -


RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) with JTI JISEDAI Telecom Incorporated for the establishment of a business relationship whereby JTI shall design, build and construct the Underground Cabling Infrastructure for the improvement of the Information Communication Technology (ICT) of the Province;
