PROVINCIAL RESOLUTION NO. 643-2023

AUTHORIZING THE HONORABLE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT BETWEEN AND AMONG THE ARMED FORCES OF THE PHILIPPINES-PHILIPPINE ARMY, PHILIPPINE NATIONAL POLICE - PANGASINAN POLICE PROVINCIAL OFFICE, BUREAU OF FIRE PROTECTION PROVINCIAL OFFICE, PHILIPPINE COAST GUARD - SUAL STATION, PROVINCIAL HOSPITAL MANAGEMENT SERVICES OFFICE, PROVINCIAL HEALTH OFFICE, PROVINCIAL VETERINARY OFFICE, PROVINCIAL AGRICULTURE OFFICE, PROVINCIAL GOVERNMENT – ENVIRONMENT AND NATURAL RESOURCES OFFICE AND THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE FOR THE INTEGRATION OF PANGASINAN 911 AND ONE RESPONSE COMMAND CENTER

WHEREAS, Executive Order No. 56, S-2018 institutionalizes the number 911 as the Nationwide Emergency Hotline Number to be known as Emergency 911 Hotline, and Section 2, Item (2) thereof likewise enjoins local government units to establish and run local 911 call centers;

WHEREAS, pursuant to Provincial Resolution No. 538-2018, the Province of Pangasinan entered into a Memorandum of Agreement with and among the Bureau of Fire Protection – Provincial Office, Pangasinan Police Provincial Office and the Philippine Coast Guard for the establishment of the Pangasinan Safety and Emergency Response Command, Control and Communications Center (PASER C3);

WHEREAS, the passage of Provincial Resolution No. 189-2023 established the Pangasinan Safety and Emergency Response, Command, Control and Communications (PASER C3) Center as the Province of Pangasinan's Emergency 911 Hotline Center, which is designed to ensure public safety and security, maintain public order and respond promptly to emergency situations in the entire Province;

WHEREAS, the PASER C3 has expanded its service to the community through the 1 Response Command Center (1RCC) Team composed of the PHMSO, PHO, PVO, PAgO and PG-ENRO;

WHEREAS, in order to fully implement its mandates, the Provincial Government of Pangasinan deemed it necessary to establish strategic checkpoints and to create 1st Responder Team composed of the Armed Forces of the Philippines-Philippine Army, Philippine National Police – Pangasinan Police Provincial Office, Bureau of Fire Protection Provincial Office, Philippine Coast Guard - Sual Station, and the Provincial Disaster Risk Reduction and the 1 Response Command Center Team;

WHEREAS, to achieve a safe and secure public order and emergency 1st response within the Province, the assistance of all the aforesaid concerned stakeholders is necessary and thereby sought;

WHEREAS, the Armed Forces of the Philippines-Philippine Army, Philippine National Police – Pangasinan Police Provincial Office, Bureau of Fire Protection Provincial Office, Philippine Coast Guard - Sual Station, and the Provincial Disaster Risk Reduction have accepted and readily acceded to the establishment of the 1st Responder and 1RCC Team pursuant to their respective mandates and programs in public service;

WHEREAS, it is the opinion of the Provincial Legal Office that the proposed MOA is in harmony with the laws, rules and regulations as set forth in the pertinent provisions of Republic Act No. 10121 (Philippine Disaster Risk Reduction and Management Act of 2010) and the Republic Act No. 7160 or the Local Government Code of 1991, thus no legal impediment was found on the provisions of the subject MOU;

WHEREAS, the Sangguniang Panlalawigan therefore expresses its support to this effort to integrate Pangasinan 911 and One Response Command Center by the Provincial Government of Pangasinan, through the assistance of the concerned stakeholders, in order that all distress calls in one command center will shorten the response time during emergencies;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between and among the Province of Pangasinan, represented by Honorable Governor, Ramon V. Guico III; Armed Forces of the Philippines - Philippine Army, represented by LTC Michael Rey L. Bautista; Philippine National Police - Pangasinan Police Provincial Office, represented by its Provincial Director, P/Col Jeff E. Fanged; Bureau of Fire Protection Provincial Office, represented by its Acting Provincial Fire Marshal, CInsp Ronaldo M. Perez; Philippine Coast Guard - Sual Station, represented by its Station Commander, CDR Mark Theodore P. Valencia; Provincial Hospital Management Services Office, represented by its Provincial Hospital Administrator, Dr. Dalvie A. Casilang; Provincial Health Office, represented by its Provincial Health Officer II, Dr. Anna Ma. Theresa S. De Guzman; Provincial Veterinary Office, represented by its OIC Provincial Veterinarian, Dr. Arcely G. Robeniol; Provincial Agriculture Office, represented by its Provincial Agriculturist, Mrs. Dalisay A. Moya; Provincial Government – Environment and Natural Resources Office, represented by its Officer-in-Charge, Ms. Vivian U.
