PROVINCIAL RESOLUTION NO. 644-2023

AUTHORIZING THE PROVINCIAL GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF DEPARTMENT AGREEMENT (MOA) WITH THE ENVIRONMENT AND NATURAL RESOURCES-ENVIRONMENTAL MANAGEMENT BUREAU (DENR-EMB)-REGION I FOR THE ASSESSMENT, SUPPLY, DELIVERY AND **BRAND-NEW** INSTALLATION OF PRELIMINARY DISINFECTION AND STORAGE FACILITY FOR COLLECTED COVID-19 RELATED WASTE IN THE PROVINCE

WHEREAS, the Department of Environment and Natural Resources-Environmental Management Bureau (DENR-EMB) is the principal agency of the government which implements and regulates hazardous waste management in the country in coordination with other partners and stakeholders;

WHEREAS, the DENR-EMB provides technical and other capability of building assistance and support to local government units in the development and promotion of hazardous waste management programs and projects;

WHEREAS, one project to be implemented by the DENR-EMB is for the assessment, supply, delivery and installation of brand-new preliminary disinfection and storage facility for collected COVI-19 related waste in the Province;

WHEREAS, the Province, in turn, shall identify a suitable site for the installation of a facility with a minimum area of fifty (50) square meters;

WHEREAS, the Project will be a huge help to the Province of Pangasinan to comply with the provisions of Republic Act 6969 or the Toxic Substances and Hazardous and Nuclear Waste Control Act of 1990, specifically in addressing the increase of waste generation from quarantine, testing and vaccination facilities;

WHEREAS, it is to the best interest of the Provincial Government of Pangasinan to enter into and sign a Memorandum of Agreement with the DENR-EMB-Region I to further augment the need for the implementation of hazardous waste management plans and programs for the Province;

WHEREAS, for the above purpose, a Memorandum of Agreement shall be entered into and signed between the Province of Pangasinan, represented by Governor Ramon V. Guico III, and the DENR-EMB-Region I, represented by Engr. Maria Dorica Naz-Hipe, Regional Director;

NOW, THEREFORE, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement (MOA) with the Department of Environment and Natural Resources-Environmental Management Bureau (DENR-EMB)-Region I for the Assessment, Supply, Delivery and Installation of Brand-New Preliminary Disinfection and Storage Facility for collected Covid-19 related waste in the Province;
