### PROVINCIAL RESOLUTION NO. 648-2023

#### DECLARING ENGINEER JAYCIEL J. BARTOLOME AS *PERSONA NON GRATA* IN THE PROVINCE OF PANGASINAN

**WHEREAS**, an unfortunate incident happened last July 19, 2023 whereby an employee of the Department of Agrarian Reform (DAR) has visited the Province of Pangasinan to conduct an ocular inspection of a project in the Municipality of Binalonan;

**WHEREAS**, one certain Engineer Jayciel J. Bartolome, a technical support staff of the Project Management Service of the Department of Agrarian Reform Central Office has berated the local engineers of the Department of Public Works and Highways-3<sup>rd</sup> Pangasinan Engineering District as well as local officials of the said municipality;

**WHEREAS**, Engineer Jayciel J. Bartolome used terms which are derogatory, insulting and uncalled for in the face of those who were present at the inspection site;

**WHEREAS**, the Sangguniang Panlalawigan denounces the unbecoming character of Engineer Jayciel J. Bartolome particularly his insulting statements to Pangasinenses who are very hospitable and respectful in nature;

**WHEREAS**, the testimonies of the engineers themselves of the DPWH-3<sup>rd</sup> Pangasinan Engineering District as well as recordings that transpired are the basis that the incident really happened in the Municipality of Binalonan;

**WHEREAS**, as such, the Sangguniang Panlalawigan is declaring Engineer Jayciel J. Bartolome as *Persona Non Grata* in the Province of Pangasinan and is no longer welcoming him to enter the borders and entire territorial jurisdiction of the Province;

**WHEREAS**, the Provincial Government of Pangasinan which is bound together by the sense of mission to commit good governance, serve with love and compassion, and perform with excellence, dynamism and innovation is in contravention to the attitude displayed by Engineer Jayciel J. Bartolome;
