RESOLUTION NO. 653-2023

DECLARING ORDINANCE NO. 05, S-2023 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE PROHIBITING GENDER-BASED SEXUAL HARASSMENT IN STREETS. PUBLIC SPACES. ONLINE PLATFORMS, WORKPLACES AND EDUCATION OR TRAINING INSTITUTIONS THE MUNICIPALITY OF BANI, PANGASINAN AND IN PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Ordinance No. 05, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Section 17 (a) (iv) of R. A. No. 7160; Republic Act No. 11313 or "Safe Spaces Act"; Republic Act No. 7877 or "Anti-Sexual Harassment Act of 1995"; Republic Act No. 9208 or "Anti-Trafficking in Persons Act of 2003"; Republic Act No. 9262 or "Anti-Violence Against Women and their Children Act of 2004"; Republic Act No. 9995 or "Anti-Photo and Video Voyeurism Act of 2009; Republic Act No. 9775 or "Anti-Child Pornography Act of 2009 and Republic Act No. 7610 or "Special Protection of Children Against Abuse, Exploitation and Discrimination Act";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was–

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 05, S-2023 of the Sangguniang Bayan of Bani, Pangasinan entitled "An Ordinance prohibiting gender-based sexual harassment in streets, public spaces, online platforms, workplaces and education or training institutions in the Municipality of Bani, Pangasinan and providing penalties for violation thereof" as within the conferred powers of the Sangguniang Bayan to enact;
