RESOLUTION NO. 654-2023

DECLARING MUNICIPAL ORDINANCE NO. 3, S-2023 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED “OTHERWISE KNOWN AS THE MABINI CODE PURSUING A PUBLIC-PRIVATE PARTNERSHIP (PPP) APPROACH TOWARDS DEVELOPMENT, PROVIDING FOR THE PROCEDURE FOR SELECTING: THE PRIVATE SECTOR PROPONENT, ADOPTING A CONTRACT MANAGEMENT FRAMEWORK, AND PROVIDING APPROPRIATIONS, AND FOR OTHER PURPOSES” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Ordinance No. 3, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 35, 106 (a) 302 (a) & 447 (a) (2) of R. A. No. 7160; Article II, Section 20 of the 1987 Philippine Constitution; Republic Act No. 7718 otherwise known as the “Revised Philippines Build-Operate-and-Transfer (BOT) Law”; and DILG Memorandum Circular No. 2016-120 dated September 7, 2016 entitled “Guidelines for the Implementation of Public-Private Partnership for the People’s Initiative for Local Government (LGU P4);

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 3, S-2023 of the Sangguniang Bayan of Mabini, Pangasinan entitled “Otherwise known as the Mabini Code pursuing a Public-Private Partnership (PPP) approach towards development, providing for the procedure for selecting: The Private Sector Proponent, Adopting a Contract Management Framework, and Providing Appropriations, and For Other Purposes” as within the conferred powers of the Sangguniang Bayan to enact;
