## **RESOLUTION NO. 659-2023**

THE APPROVING RESOLUTION NO. 134, S-2023 OF SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, SUPPLEMENTAL "APPROVING ENTITLED ANNUAL INVESTMENT PLAN NO. 2 CY 2023 OF THE LOCAL GOVERNMENT OF SAN FABIAN, PANGASINAN IN THE AMOUNT OF P31.669.159.00 FROM THE TOBACCO EXCISE TAX SHARE 2020"

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its SB Resolution No. 134, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Municipal Development Council of San Fabian, Pangasinan prepared the LGU's Supplemental Annual Investment Program (SAIP) No. 2 for CY 2023. This was endorsed by the Council, through MDC Resolution No. 02, S-2023 dated June 5, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- 2. Said Supplemental AIP, which has a total investment requirement of \$\mathbb{P}\$31,669,159.00, covers the implementation of infrastructure projects, provision of agricultural inputs and tools, financial support to tobacco farmers, and other related priority projects of the LGU;

The aforementioned projects proposed to be funded from the LGU's Tobacco Excise Tax Share (FY 2020) are based on Local Budget Memorandum No. 86 dated December 14, 2022 of the Department of Budget and Management; and

3. Funding for the Supplemental AIP is embodied in their Supplemental Budget No. 1 for CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 1, S-2023 dated June 21, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of San Fabian, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Marinor B. De Guzman and Jerry Agerico B. Rosario and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
