RESOLUTION NO. 66-2023

APPROVING RESOLUTION NO. 2022-94 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2022-07 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its SB Resolution No. 2022-94 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council (Executive Committee) of Binalonan, Pangasinan has identified items in their Supplemental Annual Investment Program No.7 for CY 2022, which was endorsed to the Sangguniang Bayan for approval on November 4, 2022 through Resolution No. 2022-06;
2. The Supplemental Annual Investment Program No. 7 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses, Capital Outlay, and implementation of other priority projects of the LGU; and

3. Said SAIP has an investment requirement of Php83,511,000.00. Funding support for the implementation of the same is embodied in their Supplemental Budget No. 3 CY 2022, which was passed and approved by their Sangguniang Bayan on November 8, 2022 through Appropriation Ordinance No. 2022-03.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Binalonan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—
