### RESOLUTION NO. 661-2023

**DECLARING MUNICIPAL ORDINANCE NO. 2023-02 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE PERSONS WITH DISABILITY AFFAIRS OFFICE (PDAO) IN THE MUNICIPALITY OF ALCALA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Alcala, Pangasinan submitted its Ordinance No. 2023-02 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 17 (b) (2) (iv), 76 & 443 (c) (2), 447 (a) (5) (xiv) of R. A. No. 7160; Republic Act No. 7277, otherwise known as the “Magna Carta for Disabled Persons”; Section 4 of the Implementing Rules and Regulations of Republic Act No. 10754 “An Act Expanding the Benefits and Privileges of Persons with Disability (PWD); Republic Act No. 10070 “Establishing Institutional Mechanism to Ensure the Implementation of Programs and Services for Persons with Disabilities in Every Province, City and Municipality, Amending Republic Act No. 7277, otherwise known as the Magna Carta for Disabled Persons, as amended and for other purposes”; Convention on the Rights of Persons with Disabilities and DILG Memorandum Circular No. 2010-103;
