### RESOLUTION NO. 662-2023

**DECLARING MUNICIPAL ORDINANCE NO. 2023-03 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED “AN ORDINANCE ESTABLISHING THE MUNICIPAL TOURISM OFFICE (MTO) IN THE MUNICIPALITY OF ALCALA, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Alcala, Pangasinan submitted its Ordinance No. 2023-03 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 443 (c) (2) & 447 (a) (1) (viii) of R. A. No. 7160 and R.A. No. 9593, otherwise known as the “The Tourism Act of 2009”;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2023-03 of the Sangguniang Bayan of Alcala, Pangasinan, entitled “An Ordinance establishing the Municipal Tourism Office (MTO) in the Municipality of Alcala, Pangasinan” as within the conferred powers of the Sangguniang Bayan to enact;
