RESOLUTION NO. 670-2023

**DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR
CALENDAR YEAR 2023 OF SAN QUINTIN, PANGASINAN
INVOLVING A TOTAL APPROPRIATION OF P19,227,764.98, AS
OPERATIVE IN ITS ENTIRETY**

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of San Quintin, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2023 involving total appropriations of P19,227,764.98, which was enacted on April 24, 2023 through Appropriation Ordinance No.1, S. 2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 417 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the appropriation for the implementation of the Fourth Tranche Compensation Adjustment shall be subject to the provisions of Local Budget Circular No. 149 of the Department of Budget & Management dated January 10, 2023;
3. That the grant of step increment to some municipal, elective officials and employees shall be in accordance with CSC-DBM Joint Circular No.1, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01 S-2016 dated January 27, 2016;
4. That the grant of Service Recognition Incentive (SRI) for FY 2023 to municipal officials & employees shall only be implemented upon issuance of a circular granting the same;
5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated March 8, 2007;
6. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A.9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations; and
7. That the disbursement of Loyalty Bonus to some municipal officials and employees shall be in accordance with Memorandum Circular No. 6 of the Civil Service Commission dated March 1, 2002.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 1 for Calendar Year 2023 of San Quintin, Pangasinan;
