**ENDORSING TO THE DEPARTMENT OF HEALTH THE
APPLICATION OF THE WESTERN PANGASINAN DISTRICT
HOSPITAL, PROVINCE OF PANGASINAN, FOR A PERMIT TO
CONSTRUCT A HEMODIALYSIS FACILITY**

WHEREAS, the Western Pangasinan District Hospital, one of the 14 hospitals operated by the Provincial Government of Pangasinan, caters to patients coming from the different municipalities and other areas from nearby localities of the 1st District of Pangasinan;

WHEREAS, at present, there is a significant increase in the number of patients being serviced by the hospital;

WHEREAS, the Provincial Government of Pangasinan, through the Western Pangasinan District Hospital, intends to construct a hemodialysis facility through the conversion of supply storage office, motorpool and TB-DOTS building into a Hemodialysis Center and establish fifteen (15) dialysis machines and other ancillary equipment thereat;

WHEREAS, the project is a great step in the quest to prolong and improve the quality of life of persons suffering from kidney problems through affordable cost;

WHEREAS, the Western Pangasinan District Hospital and its medical staff are capable in running and sustaining the operations of the hemodialysis facility;

WHEREAS, in line with the main thrusts of the present administration to have a mass-based health care program to accommodate all people especially the less fortunate sector of society, there is a need to support the plan of the Western Pangasinan District Hospital to provide a more sufficient and higher level of medical and health services to its patients by its construction of a hemodialysis facility;


