RESOLUTION NO. 677-2023

DECLARING ORDINANCE NO. 2023-18 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE ESTABLISHING THE OFFICE OF THE SENIOR CITIZENS AFFAIRS OF THE LOCAL GOVERNMENT UNIT OF THE CITY OF ALAMINOS, PANGASINAN, CREATING THE POSITION OF ADMINISTRATIVE OFFICER 1 (RECORDS OFFICER I), SG-10/I TO ASSIST IN THE MANAGEMENT OF THE OFFICE AND APPROPRIATING FUNDS THEREFOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-18 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Republic Act No. 9994, otherwise known as "Expanded Senior Citizens Act of 2010"; Sections 17 (b) (2) (iv), 76 and 454 (c) (2), 458 (a) (1) (viii) (5) and (xvii) of R. A. No. 7160; and Article XV, Section 4 of the 1987 Philippine Constitution;


