RESOLUTION NO. 678-2023

DECLARING ORDINANCE NO. 2023-19 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE PROVIDING FOR COMPREHENSIVE EMERGENCY PROGRAM FOR CHILDREN BEFORE, DURING, AND AFTER DISASTERS AND OTHER EMERGENCY SITUATIONS PURSUANT TO REPUBLIC ACT NO. 10821, OTHERWISE KNOWN AS THE "CHILDREN'S EMERGENCY RELIEF AND PROTECTION ACT" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2023-19 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer and the Local Finance Committee of the province have conducted initial review and study on said ordinance and found out that the same was enacted in accordance with Sections 16, 17 (b) (2) (iv) & 458 (a) (5) (xiv) of R. A. No. 7160; Republic Act No. 10821, otherwise known as the "Children's Emergency Relief and Protection Act"; Republic Act No. 11188 or the "Special Protection of Children in Situations of Armed Conflict Act"; Article XV (The Family) Section 3 (2) of the 1987 Philippine Constitution; DILG Memorandum Circular No. 2018-196, entitled "Guidelines on the Localization of Comprehensive Emergency Program for Children (CEPC)"; Convention on the Rights of the Child (1990) & Children's Charter for Disaster Risk and Reduction (2011);
