RESOLUTION NO. 69-2023

DECLARING MUNICIPAL ORDINANCE NO. 04-11212022 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “AN ORDINANCE PROVIDING FOR THE PAYMENT OF RENTAL FEES FOR THE USE OF THE 3-STOREY MUNICIPAL GOVERNMENT BUILDING OF THE MUNICIPALITY OF POZORRUBIO, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Ordinance No. 04-11212022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer of the Province have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 129, 132, 153 and 447 (a) (3) (i) of R.A. No. 7160;

WHEREAS, however, the Sangguniang Bayan shall consider the points raised by the Provincial Legal Officer stated in her opinion dated December 28, 2022;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirement of publication pursuant to Section 511 (a) of RA 7160;
