PROVINCIAL RESOLUTION NO. 693-2023

INVITING THE PROVINCIAL AGRICULTURE OFFICE (PAGO), PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (PDRMO), PROVINCIAL SOCIAL WELFARE AND DEVELOPMENT OFFICE (PSWDO), PROVINCIAL HEALTH OFFICE (PHO), GENERAL SERVICES OFFICE (GSO) AND THE PROVINCIAL ENGINEERING OFFICE (PEO) TO APPEAR BEFORE THE SANGGUNANG PANLALAWIGAN DURING ITS QUESTION HOUR TO REPORT ON THE STATUS OF THE AFTERMATH OF TYPHOON “EGAY” AND SOUTHWEST MONSOON RAINS IN THE PROVINCE OF PANGASINAN

WHEREAS, the Province of Pangasinan was not spared from the damages of Typhoon “Egay” that hit the country;

WHEREAS, while Typhoon “Falcon” remained far from the Philippine landmass as it moved extreme north northwest, heavy rain from the southwest monsoon or *habagat* also hit parts of Luzon area including the Province of Pangasinan;

WHEREAS, some municipalities and one city in the Province of Pangasinan suffered flooding for several days gravely affecting the livelihood and health of the residents not to mention also the extent of damages to agriculture and infrastructure, if there are any;

WHEREAS, the Sangguniang Panlalawigan would like to be enlightened if the people of Pangasinan could greatly suffer the impact of the damages wrought by the typhoon and *habagat* in the Province;

WHEREAS, the Sangguniang Panlalawigan would like to be apprised also of the necessary measures undertaken or yet to be done by the different offices to facilitate the rescue, relief and rehabilitation operations in the Province of Pangasinan;
