PROVINCIAL RESOLUTION NO. 705-2023

AUTHORIZING THE GOVERNOR, RAMON V. GUICO III, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH UNLA LA CORPORATION FOR THE IMPLEMENTATION AND UTILIZATION OF AN APPLICATION FOR THE REGULATION, INSPECTION, SUPERVISION, MONITORING AND RECORDING PROGRESS OF QUARRYING ACTIVITIES WITHIN THE TERRITORIAL JURISDICTION OF THE PROVINCE OF PANGASINAN

WHEREAS, every local government unit shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, the Unla La Corporation is a company which provides for the software services that develops an application that can conduct reliable and remote regulation, inspection, supervision, monitoring and recording of the progress of quarrying activities;

WHEREAS, the Provincial Government of Pangasinan intends to enter into a Memorandum of Agreement with Unla La Corporation for the conduct of reliable and remote regulation, inspection, supervision, monitoring and recording of the progress of quarrying activities in the Province of Pangasinan as well as ensuring that the application, alongside the hardware, operates consistently and properly throughout the duration of the project;

WHEREAS, Section 465 (vi) of the Local Government Code of 1991 provides that the Provincial Governor shall represent the Province in all its business transactions and sign in its behalf all bonds, contracts, and obligations and such other documents upon authority of the Sangguniang Panlalawigan or pursuant to law or ordinance;

WHEREAS, the duties and responsibilities of the parties are stipulated in the Memorandum of Agreement which is made an integral part of this resolution;

WHEREAS, it is to be the best interest of the Provincial Government of Pangasinan to enter into and sign a Memorandum of Agreement with the Unla La Corporation for easy access to information, easy tracking, and provide real-time updates in the quarry collection by the enforcers;

NOW, THEREFORE, in view of the foregoing, on motion of SP Member Vici M. Ventanilla, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to authorize, as he is hereby authorized, the Provincial Governor, Ramon V. Guico III, to enter into and sign a Memorandum of Agreement with Unla La Corporation for the implementation and utilization of an application for the regulation, inspection, supervision, monitoring and recording progress of quarrying activities within the territorial jurisdiction of the Province of Pangasinan;
