EXPRESSING WARMEST CONGRATULATIONS TO DR. CHRISTINE NABOR FERRER FOR BEING APPOINTED AS REGIONAL DIRECTOR OF THE COMMISSION ON HIGHER EDUCATION - REGIONAL OFFICE 1

WHEREAS, Dr. Christine Nabor Ferrer, a native daughter of Malasiqui, Pangasinan, has put the Province in the helm of honor, integrity and pride for her recent appointment as Regional Director of the Commission on Higher Education (CHED) – Regional Office 1, a government agency under the Office of the President of the Philippines which is responsible for regulating and governing all higher education institutions and post-secondary educational programs in the country;


