**PROVINCIAL RESOLUTION NO. 708-2023**

**APPROVING THE UTILIZATION OF THE SPECIAL TRUST FUND AS EMBODIED IN THE SUPPLEMENTAL LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP) IN THE TOTAL AMOUNT OF P197,652,000.00 FOR THE PROCUREMENT OF DISASTER RISK REDUCTION AND MANAGEMENT (DRRM) CONSTRUCTION AND HEAVY EQUIPMENT AND APPROVING THE REVISED ANNUAL INVESTMENT PROGRAM (AIP) CY 2023 OF THE PROVINCE OF PANGASINAN**

**WHEREAS**, presented for consideration by the Sangguniang Panlalawigan is the Revised Annual Investment Program (AIP) of the Province of Pangasinan for CY 2023 as endorsed by the Provincial Development Council through PDC Execom Resolution No. 04-23;

**WHEREAS**, the AIP CY 2023 of the Province of Pangasinan was approved by the Sangguniang Panlalawigan on November 7, 2022 through Provincial Resolution No. 847-2022 to accommodate programs and projects which are deemed necessary in the development of the Province;

**WHEREAS**, there is a need to revise the AIP to include disaster risk reduction management related programs and projects specifically the acquisition of various DRRM construction and heavy equipment to be funded out of the Special Trust Fund in the amount of P197,652,000.00;

**WHEREAS**, said DRRM related programs and projects emanated from the Provincial Disaster Risk Reduction Management Council and approved through PDRRMC Resolution No. 3, S-2023;
