RESOLUTION NO. 710-2023

DECLARING THE SUPPLEMENTAL BUDGET NO. 1 FOR CALENDAR YEAR 2023 OF DASOL, PANGASINAN INVOLVING A TOTAL APPROPRIATIONS OF P38,233,444.42, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Supplemental Budget No. 1 for Calendar Year 2023 involving total appropriations of P38,233,444.42, which was enacted on June 27, 2023 through Appropriation Ordinance No. 181;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

1. That the funding sources for the subject supplemental budget were determined in accordance to Section 321 of R.A. 7160 and Article 414 (a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

2. That the appropriation for Terminal Leave Benefits shall be subject to the provision of DBM Budget Circular No. 2016-2 dated March 29, 2016 Re: Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;
3. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its Implementing Rules and Regulations;
4. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and the FY 2023 Annual/Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2017 dated March 8, 2007;
5. That the grant of Productivity Enhancement Incentive (PEI) shall be subject to the provisions of Budget Circular No. 2017-4, specifically Section 6.2 thereof; and
6. That the utilization of appropriations from 20% Development Fund shall be in accordance with the provisions of DBM - DOF - DILG Joint Memorandum Circular (JMC) No. 1 dated November 4, 2020 re "Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment for Development Projects".

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Apolonia DG. Bacay and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was—

RESOLVED, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Supplemental Budget No. 1 for Calendar Year 2023 of Dasol, Pangasinan;




