DECLARING MUNICIPAL ORDINANCE NO. 39, S-2023 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AN ORDINANCE REGULATING CHILDBIRTH HOME DELIVERIES IN THE MUNICIPALITY OF AGUILAR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Ordinance No. 39, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted in accordance with Sections 16 and 17 (b) (2) (iii) of R. A. No. 7160 and the Department of Health Administrative Order 2008-0029, otherwise known as the "Implementing Health Reforms for Rapid Reduction of Maternal and Neonatal Mortality";

WHEREAS, the subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of R.A. No. 7160;
