**APPROVING RESOLUTION NO. 2023-21 OF THE SANGGUNIANG BAYAN OF SAN MANUEL, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL INVESTMENT PROGRAM NO. 2023-01 OF THE SUPPLEMENTAL BUDGET NO. 2023-01 OF THE MUNICIPALITY OF SAN MANUEL, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of San Manuel, Pangasinan submitted its SB Resolution No. 2023-21 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. Subject Resolution is in consonance to Sections 106, 109 and 114 of the Local Government Code (LGC) of 1991. The Local Development Council of San Manuel, Pangasinan has identified programs/projects in the Supplemental Investment Program (SIP) No. 01. This was endorsed to the Sangguniang Bayan for approval through MDC Resolution No. 02, Series of 2023 dated April 20, 2023;
2. The Supplemental Investment Program No.01 with a total investment requirement amounting to PhP5,454,560.75 covers the implementation of various projects (Asphalt Overlay Along Ambassador Ramos Street in Brgy. Gueset Sur, Rehabilitation of Road and Line Canal in Brgy. Gueset Norte and Installation of Normal and Emergency Power Cables to San Manuel Multi-Purpose Gym) in LGU San Manuel; and

3. Funding support for the full implementation of this Supplemental Investment Program is embodied in the Supplemental Budget No.01 for CY 2023 which was enacted by the Sangguniang Bayan through Appropriation Ordinance No. 01, Series of 2023 on April 26, 2023.
