APPROVING RESOLUTION NO. 86, S-2023 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 02, CY 2023"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its SB Resolution No. 86, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

- The Municipal Development Council of Aguilar, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 2, CY 2023 of the LGU. This was endorsed by the Council, through MDC Resolution No. 5, S. 2023 dated May 8, 2023, to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
- Said Supplemental AIP No. 2, CY 2023, which has a total investment requirement of ₱25,360,500.00, covers the augmentation of funds for Personal Services, Maintenance and Other Operating Expenses, and Capital Outlay of the LGU offices, and implementation of priority projects of the municipality, including LDRRM projects/activities;

- 3. The projects/activities proposed to be funded from the 5% LDRRM Fund are based on Section 21 of RA 10121 (Philippine DRRM Act of 2010) and Joint Memorandum Circular No. 2013-1 of the NDRRMC, DBM & DILG dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund); and
- Funding for the Supplemental AIP is embodied in the LGU's Supplemental Budget No. 2, CY 2023, which was enacted by their Sangguniang Bayan through Appropriation Ordinance No. 02, Series of 2023 dated June 13, 2023.

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Aguilar, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 86, S-2023 of the Sangguniang Bayan of Aguilar, Pangasinan, entitled "Approving the Supplemental Annual Investment Plan of Supplemental Budget No. 02, CY 2023";
