#### **RESOLUTION NO. 718-2023**

#### DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2023 OF AGUILAR, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P25,360,500.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2023 involving total appropriations of P25,360,500.00, which was enacted on June 13, 2023 through Appropriation Ordinance No. 02, Series 2023;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted review and study on said budget with the following findings:

 That the funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of R.A. No. 7160 and Article 417(a) of its IRR as amended by Administrative Order No. 47 dated April 12, 1993;

- That the disbursement of appropriation for Terminal Leave Benefits shall be subject to the provisions of DBM Budget Circular No. 2016-2 dated March 29, 2016 re Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, which provides for the new constant factor stated under Item 3.1 thereof;
- That the purchase of motor vehicles shall be subject to the provisions of Budget Circular No. 2022-1 of the Department of Budget and Management dated February 11, 2022 re "Omnibus Guidelines on the Acquisition, Use, Rental, And Replacement of Government Motor Vehicles";
- 4. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A. No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the DBM - NDRRMC - DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
- 5. That all programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2023 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, Series of 2007 dated 08 March 2007; and
- 6. That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

WHEREFORE, in view of the foregoing, on motion of SP Members Philip Theodore E. Cruz and Haidee S. Pacheco and co-sponsored by SP Members Jerome Vic O. Espino, Jeanne Jinky C. Zaplan and Arthur C. Celeste, Jr., duly seconded, it was-
