### RESOLUTION NO. 719-2023

**APPROVING MUNICIPAL RESOLUTION NO. 87, S-2023 OF THE SANGGUNIAN BAYAN OF AGUILAR, PANGASINAN, ENTITLED “APPROVING THE REALIGNMENT IN THE AMOUNT OF SIX MILLION PESOS (P6,000,000.00) FROM 2023 DEVELOPMENT FUND (20% OF NTA) TO FUND MORE PRESSING PROJECTS OF THE MUNICIPALITY OF AGUILAR, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its SB Resolution No. 87, S-2023 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution with the following findings:

1. The Municipal Development Council of Aguilar has proposed for the realignment/reprogramming of projects amounting to a total of P6,000,000.00 from the 20% Development Fund (CY 2023) of the LGU. This was endorsed by the Council through MDC Resolution No. 4, Series of 2023 dated May 8, 2023 to the Sangguniang Bayan for approval. This is in accordance to Sections 106, 109 and 114 of the Local Government Code of 1991;
